Section 2 - Hazard Identification

Emergency Overview: Harmful if inhaled or swallowed. Highly flammable. Keep away from sources of ignition - No smoking.

Potential Health Effects:

Eyes: May cause irritation.

Skin: May cause irritation to skin.

Ingestion: May cause gastrointestinal discomfort.

Inhalation: May cause irritation to respiratory tract.

Emergency and First Aid Procedures:

Eyes - In case of contact with eyes, rinse immediately with plenty of water and seek medical advice.

Ingestion - If swallowed, do not induce vomiting; seek medical advice immediately and show this container or label.

Inhalation - In case of accident by inhalation: remove casualty to fresh air and keep at rest.
