3. Hazards Identification:

* Human Health Hazards: None when used properly

* Hazardous Reactions: None when used properly

4. First - Aid - Measures:

* General: In all cases of doubt, or when symptoms persist, seek medical attention. Remove contaminated clothing and wash before reuse.

* Inhalation: If respiratory discomfort or irritation occurs, move the person to fresh air. See a doctor if discomfort or irritation continues

* Skin contact: Wash skin with soap and water. If irritation occurs, get medical attention.

* Eye contact: In case of contact, flush eyes with plenty of water and get medical attention.

* Ingestion: Get medical attention immediately. Do not induce vomiting.

5. Fire Fighting Measures:

* Extinguishing media: Foam, carbon dioxide, dry chemical, sand, and water fog. Do not use water jet.

* Special exposure hazards: Do not breathe fumes.

* Hazardous decomposition / combustion products: Carbon Oxides, Nitrogen Oxides, and Smoke.

* Protective equipment: Wear full protective gear. Wear self-contained breathing apparatus.

6. Accidental Release Measures:

* Personal precautions:

The usual precautions for handling chemicals should be observed.

Wear respirator if fumes, mist or aerosols exceed exposure limits.

Spilled product may cause floor to become slippery.

* Environmental precautions: Do not allow to enter drains, waterways or the soil. Prevent spillage from spreading by using an absorbent media. Should there be leakages into surface water, drains channels or waterways, advise the appropriate authorities.

* Clean - up methods: Absorb or contain liquid with spill control material. Shovel into a suitable, clearly marked container for disposal in compliance with local regulations. In case of larger spillages, prevent these from spreading.

7. Handling and Storage:

* Handling:

Avoid prolonged contact with skin and clothing. Avoid generating mist. Use with adequate ventilation. Wash thoroughly after handling.

* Storage: Keep container tightly closed. Store in cool, dry place, out of direct sunlight. Do not cut, grind, drill, weld, containers. Reuse or dispose of containers properly.

* Engineering control measures:

Provide adequate ventilation to keep airborne concentrations of mist and vapors below exposure limits.

None usually required. Avoid breathing vapors, fumes, and mist.

*** Eye - Protection:**

Industrial safety glasses, safety splash glasses or goggles. Avoid contact with the eyes.

Wear normal industrial clothing. Avoid contact with skin and clothing.
